Bloomberg EM Tradable Russian Corporate Bond (EMRUS) Index

The Bloomberg Barclays EM Tradable Russian Corporate Bond (EMRUS) Index is designed to measure the performance of a basket of short-maturity Eurobonds from Russian non-sovereign issuers. Index rebalancing occurs twice a year on the last business day of May and November. Index issuer eligibility, security selection, and security weights are calculated as of the 20th calendar day of the rebalancing month, with index composition then reset at May and November month ends.

Changes to the index as a result of the Nov 2020 rebalancing are as follows:
