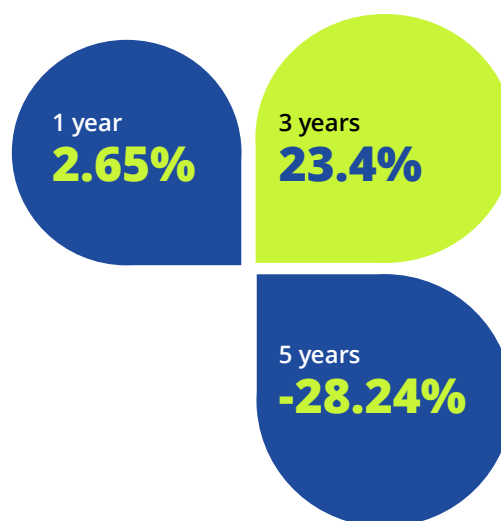
Investment Objective

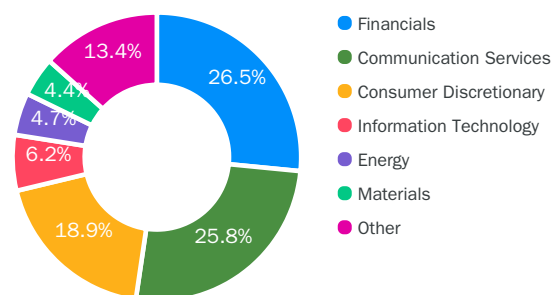
