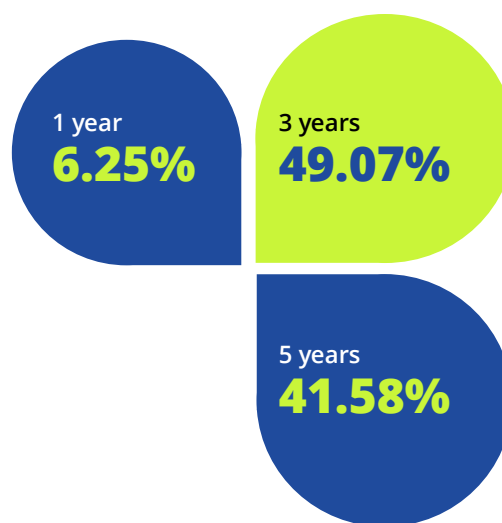
Investment Objective

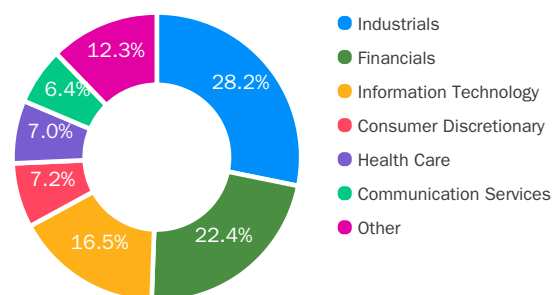
