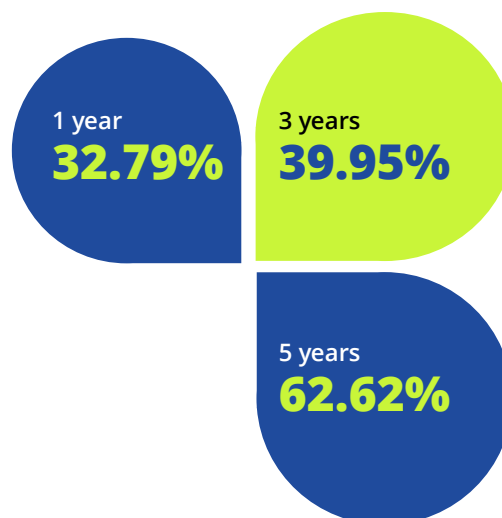
Investment Objective
