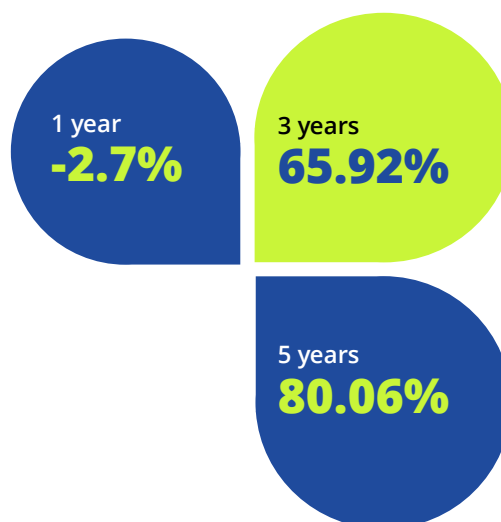

Share class return for (RUB, %)*:

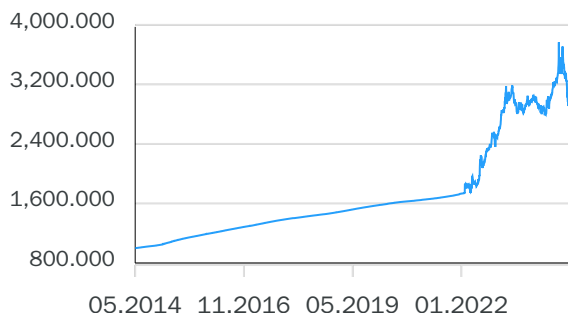

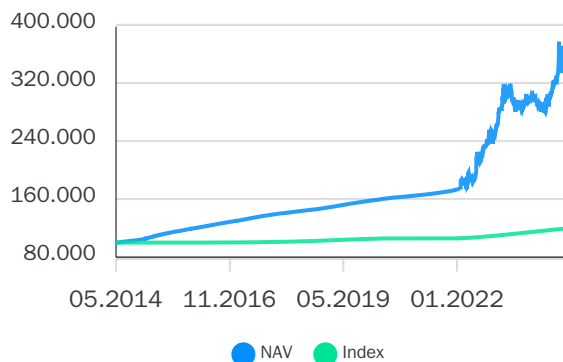
