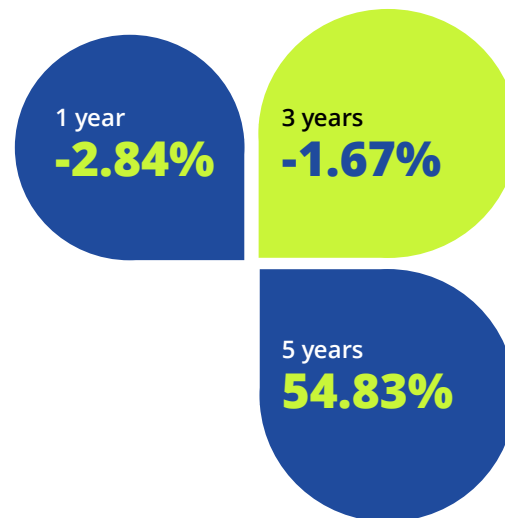
Investment Objective

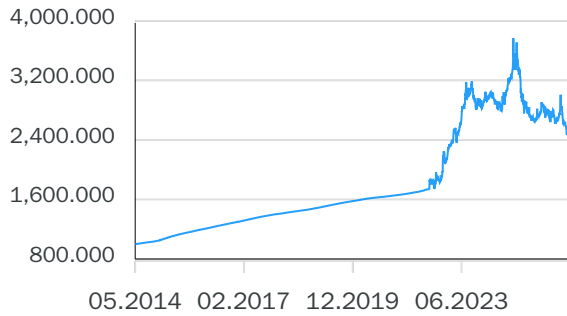

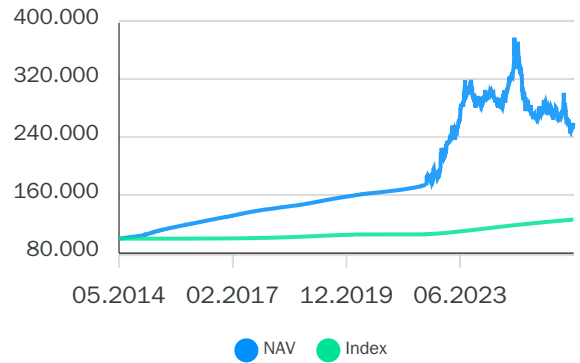
