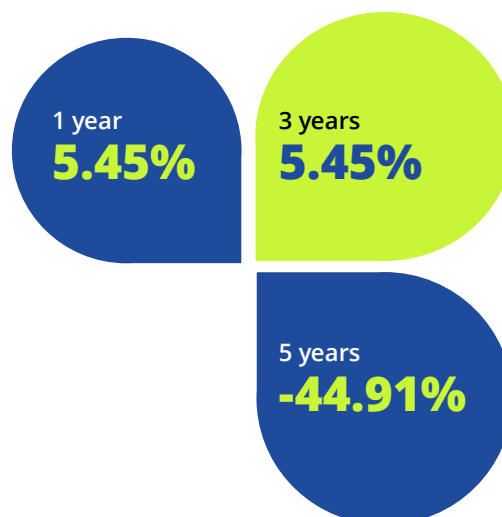
Investment Objective

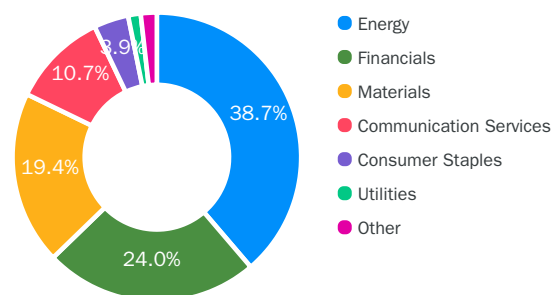
