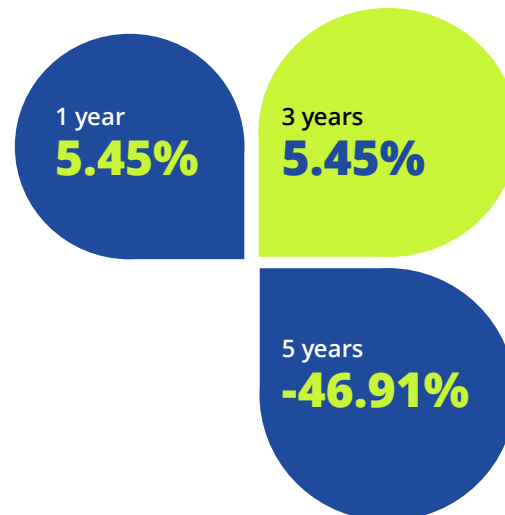
Investment Objective

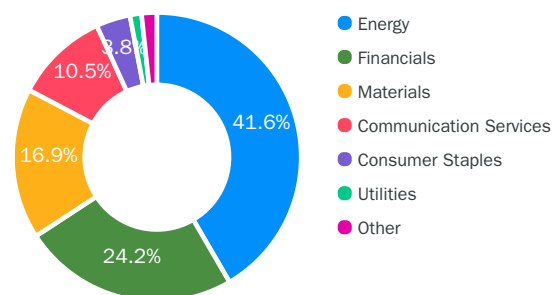
