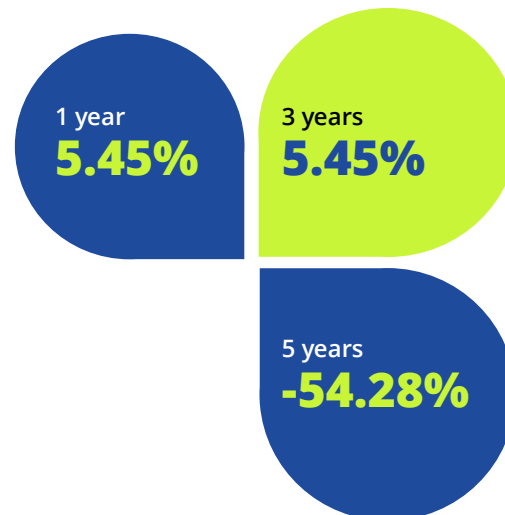
Investment Objective

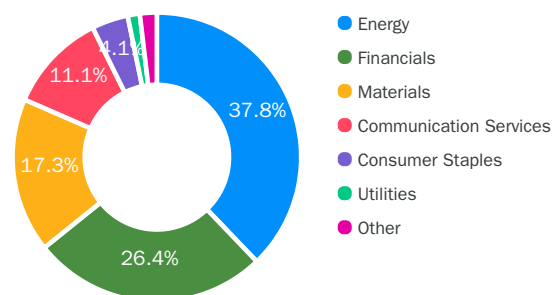
