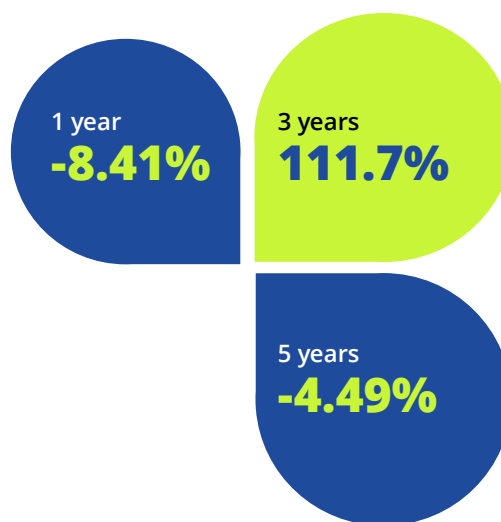
Investment Objective

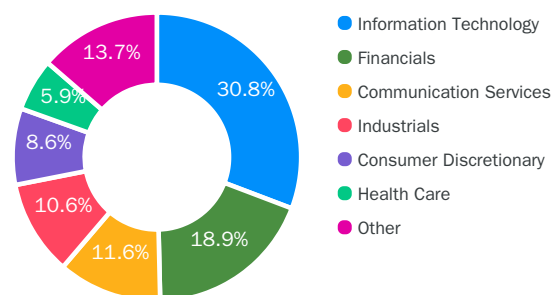

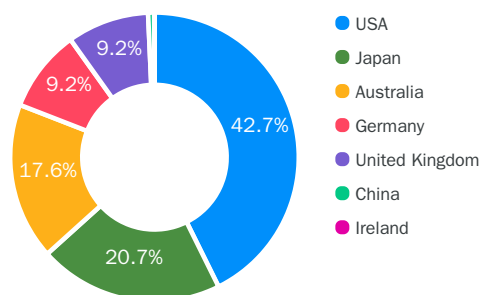
