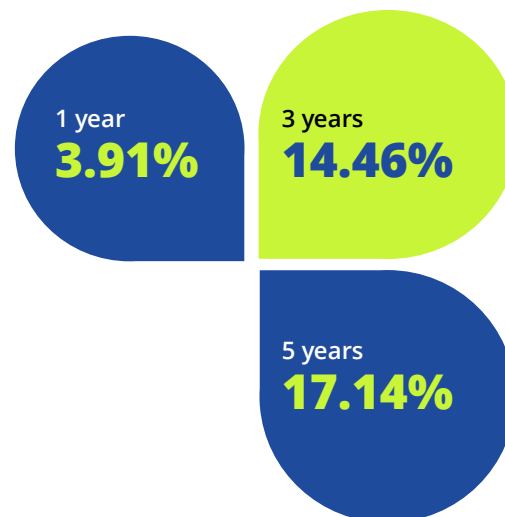
## Investment Objective

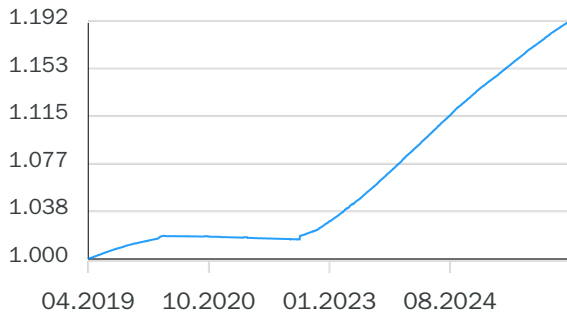

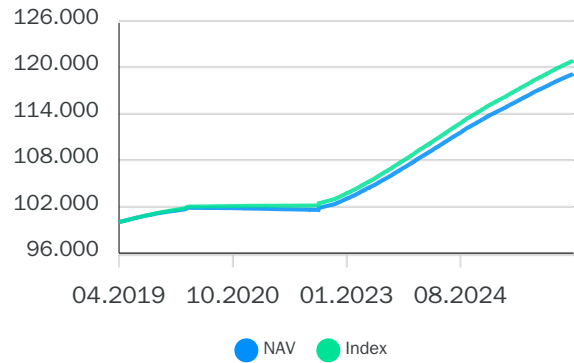
