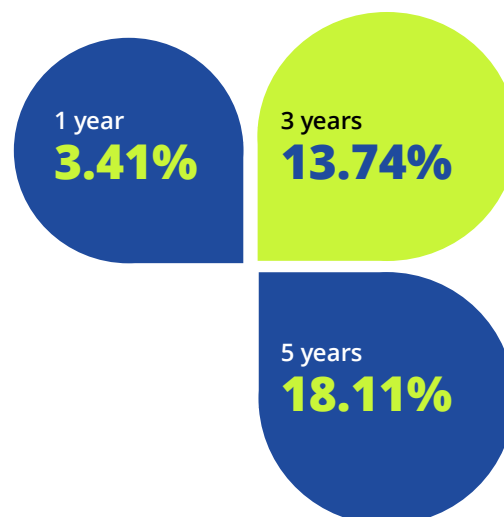
Investment Objective

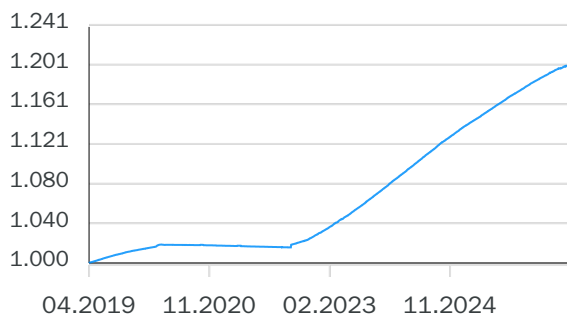

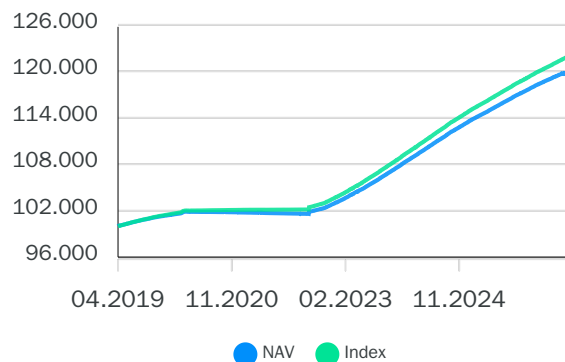
